Jozef Síkela



Jozef Síkela is the Minister of Industry and Trade of the Czech Republic since December 2021. Prior to that, he was a member of the Management Board of Erste Group, Austria. Responsible for Corporate & Investment Banking, Commercial Real Estate, Capital Markets, Treasury Sales and Financial Institutions, Research in Erste Group Core & Home Markets (Austria, Croatia, Czechia, Hungary, Romania, Serbia, Slovakia, Bosnia, Montenegro & Slovenia and for Erste Group Bank Branches in New York, Hong Kong & London, for Erste Group Immorent AG, Erste Securities Polska, S.A. and German Offices. Before that, he was a Chief Executive

Officer of Erste Bank Ukraine. He graduated as an economic engineer in 1991. In the same year, he was selected in an audition to join the prestigious banking study programme of the Austrian Creditanstalt AG in Vienna, where he worked until 1995.

Maroš Šefčovič



Maroš Šefčovič is a Slovak diplomat and politician serving as European Commission Vice-President for Interinstitutional Relations and Foresight since 2019. Prior to this, he served as European Commissioner for Education, Training, Culture and Youth from 2009 to 2010, Vice-President of the European Commission for Interinstitutional Relations and Administration from 2010 to 2014. Since 2014 to 2019 he served as the Commission's Vice-President in charge of the Energy Union. Earlier he was a Director-General of the European Affairs Section, Slovak Ministry of Foreign Affairs and later Slovak Permanent Representative to the EU.

Maroš Šefčovič holds Ph.D. in international and European law, Comenius University in Bratislava and Doctor Honoris Causa, Pan-European University in Bratislava.

Thierry Breton



Thierry Breton is the European commissioner for the internal market, a position he has held since December 1, 2019. Before that, he was the chief executive officer of the French technology company Atos from 2008 to 2019. He was also minister for the economy, finance and industry for France from to 2005 to 2007, as well as chief executive officer of France Telecom from 2002 to 2005 and of Thomson Multimedia from 1997 to 2002. Prior to that, he was director for strategy and development, then director-general of the computer company Bull from 1993 to 1997. His previous political experience also includes the vice-presidency of the

Poitou-Charentes Region in France from 1986 to 1986 and his role as an adviser to the French Minister for Education René Monory from 1986 to 1988. Breton received a master's degree in electrical engineering and computer science from École Supérieure d'Électricité (Supélec, now CentraleSupélec) in 1979 and later graduated from the Institut des Hautes Etudes de Défense Nationale (IHEDN).

Agnès Pannier-Runacher



Agnès Pannier-Runacher is currently Minister for Energy Transition of France. Prior to this, she held the role of the Deputy Minister to the Minister of Economy and Finance. Prior to joining the Government in 2018, she was Deputy Chief Executive Officer at Compagnie des Alpes. Furthermore, Agnès was Customer Business Unit Director at Faurecia Interior Sustems, Executive Director at Fonds stratégique d'investissement, Deputy Director of Finance and Strategy at Caisse des Dépôts et Consignations, and chief of staff at Assistance Publique - Hopitaux de Paris. She was a Board director and chairperson of audit committees of various industrial and financial companies between 2006

and 2018. She graduated from HEC and ENA civil service school and she holds CEMS Master's degree.

Jan Moström



Jan Moström is currently President and Chief Executive Officer at LKAB. Jan Moström joined LKAB in 2015. Between 2005 and 2015, he was Boliden's director of mining, with the responsibility for all of the company's mines. Jan Moström was also a member of the Steering Committee of Euromines. 
Joaquim Nunes de Almeida

He is the director in charge of "Green and Circular Economy" at DG GROW, which includes the Circular Plastics Alliance. From 2013 he was the director in charge of various single market policies (procurement, free movement of goods and enforcement). Joaquim Nunes de Almeida started his career at the European Commission in 1995 and has extensive experience in policies related to the internal

market and home affairs (police cooperation, terrorism, law enforcement, asylum and immigration). Joaquim Nunes de Almeida studied law and worked as a lawyer at the Bar of Lisbon, Portugal, from 1989 to 1994, dealing mainly with anti-trust law as well as commercial and civil law.

Zdeněk Venera is the Director of the Czech Geological Survey. He was elected President (2019 – 2021) and a member of the Executive Committee of the Association of European Geological Services EuroGeoSurveys. From 1998 to 2003 he was the Director of the Geology Department of the Ministry of the Environment. Graduated from the Faculty of Science of Charles University in Prague (1990) and from the Faculty of Arts of Charles University in Prague (1990). Zdeněk Venera worked as an assistant at the Department of Mineral Resources and at the Institute of Petrology and Structural Geology at the Faculty of Science of Charles University. From

2004 to 2005, he was a Fulbright Scholar at the University of California at Davis and at the U.S. Geological Survey in Menlo Park.
